SensibleAI Studio™ - Standard20

Overview

The Solutions identified in this OneStream Solutions Description Guide are each separate and individual SKUs, but may be packaged in a bundle, as further outlined in your Order Schedule. Solutions may be categorized as either “Standard” or “Reporting” as further specified below.

Standard

Standard Solutions have full access and use rights to all functionality, including read and write access, in the specific Solution.

Standard Solutions permit an Authorized Person to change data in a cube, relational table, or other modeling apparatus including:

- Accessing functionality under the “Application” or “System” tabs in the OneStream Windows Desktop application or the equivalent functionality in other user interfaces
- Modifying values stored in a cube or relational table
- Executing actions that run calculations, such as Calculate, Translate, or Consolidate
- Importing data through the Stage engine or other data ingestion mechanisms
- Modifying predefined reports or dashboards
- Executing data management jobs or tasks that modify stored data

Reporting

Reporting Solutions are limited to read-only access by Authorized Persons, including:

- Viewing Cube Views and Dashboards
- Exporting data to Excel
- Accessing data through the OneStream Excel Add-in
- Selecting a parameter for the purpose of rendering a predefined report
- Viewing workflows and steps embedded therein
- Viewing documents stored within the OneStream service

Platform - Standard

Platform - Standard consists of full access and use rights to the core functionality of the OneStream SaaS platform including:

- Access to download, install, and utilize the OneStream Windows Desktop Application, OneStream Excel Add-in, and Modern Browser Experience
- Interaction with Workflows, Cubes, Cube Views, Dashboards, Documents, and Data Collection and Quality

Service Limits – SensibleAI Forecast

OneStream SensibleAI Forecast is a separately priced product, and additional fees will apply based on the number of Targets defined in the customer Order Schedule.

“Target” means a data element in the SensibleAI Solution in which: i) Customer historical data is ingested; and ii) forecast data is generated by the SensibleAI Solution. Targets are consumed across both production and non-production environments.

SensibleAI Studio - Standard consists of full access and use rights to the following application from the OneStream Solution Exchange:

Service Limits – SensibleAI Essentials Package and SensibleAI Studio - Standard

1. A maximum of 3000 Invocations per calendar quarter of LLM Chat Models surface through SensibleAI Studio and Xperiflow Business Rules.
2. A maximum of 300,000 LLM Embedding Generations per calendar quarter.
3. A maximum of 100,000 Code Scan Units per calendar quarter.

Any unused Invocations, LLM Embedding Generations or Code Scan Units may not be rolled over and consumed during a subsequent calendar quarter.

“Invocation” means a single call or execution of a service, function, or model within the Platform.

“LLM Embedding Generation” means single operation where an LLM embedding model processes one discrete sub-set of text to produce its numeric embedding representation.

“Code Scan Unit” means single evaluation that checks a specific code file ("Scan Item") against one Condition, returning any matching instances within that file.

“Condition” means predefined coding pattern or issue (e.g., "Unnecessary Logging Statements", "Nested SQL loops") that the scanning process searches for within a Scan Item.
